TRANSET CALL FOR EXPRESSIONS OF INTEREST FOR HERITAGE RAIL ROLLING STOCK

Following the circulation of incorrect documentation relating to the call for Expressions of Interest in rolling stock (locomotives and coaches), Brian Murison (Heritage Manager, TF) has advised that **ALL** previous lists issued by any source are hereby withdrawn with immediate effect and are replaced as follows:.

- 1) Locomotives: The attached **SAHRA FINAL LIST** will be the **ONLY** document to be consulted in the process in a call for Expressions of Interest (EOI) for the locomotives.
- 2) Coaches: EOIs for the coaches will be addressed via the attached list entitled **TF Rolling Stock – Coaches_Disposal_Lend-Lease_09.10.2013**.

Submission of EOIs:

PLEASE NOTE:

- The submission of an EOI for either Disposal Sale or Lend-Lease (LL) does not guarantee that the asset will be allocated to the applicant as a specific verification process will be applied.
- Mr Murison will not entertain any enquiries or EOIs sent directly to him.

Existing, Pending and New Lend-Lease applications:

- Existing Lend-Lease (signed LL agreements) will be renewed applying a specific verification process.
- Pending LL applications must be re-submitted as new applications, also subject to the same verification process.
- New LL applications will also be subjected to the same verification process.

PROCESSES AND DEADLINES

Expressions of Interest (EOIs) – Locomotives and Coaches ON C-List:

- Step 1: Submit EOIs for locos and coaches – deadline 31 October 2013. This deadline will not be extended
- Step 2: Information required for verification process to be circulated to HRASA members by 10 October 2013.
- Step 3: All information required from applicants to be submitted to HRASA for verification process – deadline 31 October 2013.
- Step 4: Verification process to be completed – deadline 14 November 2013.
- Step 5: EOIs and member verifications to be submitted to TF by HRASA – deadline 15 November 2013.
- Step 6: TF and HRASA to process applications – deadline to finalise 20 December 2013.

Expressions of Interest (EOI) – Locomotives on B-List:

Step 1: Submit EOIs for locos – deadline 14 November 2013.

Step 2: All information required from applicants to be submitted to HRASA for verification process – deadline 14 November 2013.

Step 3: Verification process to be completed – deadline 07 December 2013.

Step 4: EOIs and member verifications to be submitted to TF by HRASA – deadline 20 December 2013.

Step 5: TF and HRASA to process applications – deadline to finalise TBA.

Expressions of Interest (EOI) – Locomotives on A-List:

Step 1: Submit EOIs for locos – deadline 30 November 2013.

Step 2: All information required from applicants to be submitted to HRASA for verification process – deadline 30 November 2013.

Step 3: Verification process to be completed – deadline 07 December 2013.

Step 4: EOIs and member verifications to be submitted to TF by HRASA – deadline 20 December 2013.

Step 5: TF and HRASA to process applications – deadline to finalise TBA.
